ORDINANCE NO. 19-15

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING A RESIDENT ONLY HANDICAPPED PARKING ZONE ON LAWRENCE AVENUE, CONVERTING AN EXISTING HANDICAPPED ZONE TO A RESIDENT ONLY HANDICAPPED ZONE ON EMBURY AVENUE AND REMOVING A RESIDENT ONLY HANDICAPPED PARKING ZONE ON PENNSYLVANIA AVENUE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Lawrence Avenue	1	East side of Lawrence Avenue beginning 52 feet south of the southeast intersection of Lawrence Avenue and Abbott Avenue
Embury Avenue	1	North side of Embury Avenue beginning 25 feet west of the northwest intersection of New York Avenue and Embury Avenue

SECTION 2

Volume I, Chapter VII, Section 7-21.7 – Resident Handicapped On-Street Parking, is hereby amended by *removing* the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Pennsylvania Avenue	1	East side of Pennsylvania Avenue beginning 30 feet south of the southeast intersection of Pennsylvania Avenue and Asbury Avenue

SECTION 3

Volume I, Chapter VII, Section 7-21.1 – Handicapped Parking on Street, is hereby amended by deleting the Embury Avenue location described in Section 1.

SECTION 4

This ordinance shall take effect upon publication in accordance with law.
