ORDINANCE NO. 11-30

AN ORDINANCE AUTHORIZING A LEASE AGREEMENT  
BETWEEN THE COUNTY OF MONMOUTH AND THE MONMOUTH  
COUNTY SHERIFF'S OFFICE AND THE TOWNSHIP OF NEPTUNE

WHEREAS, Neptune Township (Landlord) owns property recently purchased and commonly known as the "Neptune Township Senior Center" at 1825 Corlies Avenue (State Route 33), Neptune Township, New Jersey; and,

WHEREAS, Neptune Township by resolution has authorized a Shared Service Agreement between Neptune Township and the County of Monmouth and the Monmouth County Sheriff's Office wherein the County shall provide direct emergency dispatch services for police, fire, emergency management and emergency medical services for the municipality; and,

WHEREAS, it is in the best interest of the Township to provide space for such services at the aforesaid address for a term of five (5) years commencing July 1, 2011 at an agreed upon rent to the Landlord from the tenant of \$150,000.00 per annum to use such property solely for emergency communications services per the Shared Service Agreement,

NOW, THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Neptune, County of Monmouth and State of New Jersey that pursuant to State Statute allowing municipalities to lease public property for public use the governing body hereby authorizes a lease agreement aforesaid as Exhibit A, attached hereto, between Neptune Township and the County of Monmouth and the Monmouth County Sheriff's Office for the sole purpose of implementing the Shared Service Agreement between the parties and providing for the municipality emergency dispatch services for police, fire, emergency management and emergency medical services.

BE IT FURTHER ORDAINED, that the Township Committee authorizes the use of the "Neptune Township Senior Center" at 1825 Corlies Avenue (State Route 33), Neptune Township, New Jersey and sets forth the requirements for the use of said property in the attached Exhibit A

lease agreement.

BE IT FURTHER ORDAINED, that the Mayor and Clerk are authorized to execute the attached lease agreement.

BE IT FURTHER ORDAINED, that this Ordinance shall go into effect upon adoption and advertisement according to law.
