

# SNOW EMERGENCY INFORMATION

## **NO PARKING REGULATIONS;**

For purposes of providing effective snow removal and ensuring adequate access for emergency vehicles to all areas of Neptune Township, a Snow Emergency is declared **when the roads become snow covered**. When a Snow Emergency is in effect, parking is prohibited in areas indicated by signs. **In areas where signs are not present, parking is prohibited on the North and West sides of all public roadways.** Vehicles that are not moved may be towed at the owners expense. The Township will attempt to clear the South End Parking Lot at Broadway & Central and Ocean Avenue in the Ocean Grove section for those who have difficulty locating other parking.

## **13-2 REMOVAL OF SNOW AND ICE.**

### **13-2.1 Responsibility for Removal; Time.**

The tenants of lands abutting or bordering upon the sidewalks of the public streets and highways in the Township shall remove, or cause to be removed, from the sidewalks in front of or bordering on their lands all snow and ice within twelve (12) hours of daylight after the same shall be formed or fall thereon. (Ord. No. 1369 § 1)

### **13-2.2 Township May Remove.**

In case such owner or owners, tenant or tenants of any land abutting or bordering upon any street, avenue or highway in said Township shall neglect or refuse to remove such snow and ice within twelve (12) hours of daylight after the same shall have fallen or formed, it shall be the duty of the duly authorized officer having charge of the streets and highways of the Township to remove or cause to be removed such snow and ice from the sidewalks in front of or bordering on such lands. ### **13-2.3 Cost of Removal by Township; Lien Against Property.**

The cost paid and incurred by such officer for removing snow and ice from any sidewalk shall be certified by him/her to the Township Committee, which shall examine such certificate and shall cause the cost as shown thereon to be charged against the lands abutting or bordering such sidewalk; and the amount so charged shall forthwith become a lien upon such lands and shall be added to and become and form part of the taxes then next assessed and levied upon such lands and shall be collected and enforced according to law. (Ord. No. 1369 § 3)

### **13-2.4 School Zones.**

Residents living within areas found to be one thousand (1,000') feet from schools and which have been designated by signs, as Drug Free Zones due to their close proximity to schools shall be required to clear all sidewalks abutting or bordering their property of snow and ice within twelve (12) hours of daylight after the same shall be formed or fallen thereon. These school areas are designated by signs:

- a. *Whiteville.*
  - 1. Sign 1 on Route 35 facing north between Bradford and Olden Avenues.
  - 2. Sign 2 on Neptune Boulevard facing north, south of Bangs Avenue.
- b. *Montessori.*
  - 1. Sign 1 on Asbury Avenue, facing east just west of Vanada Drive.

2. Sign 2 on Asbury Avenue, facing west, east of Colgate Avenue.
- c. *Jumping Brook Fields.*
1. Sign 1 on Jumping Brook Road, facing south, south of Country Drive.
  2. Sign 2 on Jumping Brook Road, facing north, south of Route 66.
- d. *Shark River School.*
1. Sign 1 on Brighton Avenue, facing north at the foot of Schock Avenue.
  2. Sign 2 on Brighton Avenue, facing south, just north of Lakewood Road.
- e. *Summerfield School.*
1. Sign 1 on Route 33, facing east, at Hawthorne Avenue.
  2. Sign 2 on Green Grove Road, facing north at Squirrel Road.
- f. *Ridge Avenue School.*
1. Sign 1 on Route 33, facing east, just west of Atkins Avenue.
  2. Sign 2 on Route 33, facing west, just west of Route 33.
- g. *Neptune Senior High; Neptune Junior High; Gables School; Monmouth County Vocational.*
1. Sign 1 on Route 33, facing west, west of Stanley Avenue.
  2. Sign 2 on Route 33, facing east, just east of Taylor Avenue.
  3. Sign 3 on Heck Avenue, facing east, 150 yards of Taylor Avenue.
  4. Sign 4 on Bangs Avenue, facing west just before intersection of West Lake Avenue, and Bangs Avenue.
  5. Sign 5 on Wakefield Road, facing south on Brixton Place.
- h. *Holy Innocents.*
1. Sign 1 on West Bangs, facing East Shore Brook Circle, east section, north side of street.
  2. Sign 2 on Route 33, facing west, at Old Corlies Avenue.
- i. *Green Grove School.*
1. Sign 1 on Route 66, facing east, just east of Yale.
  2. Sign 2 on Route 66, facing west, after Mancino's Lodge.
  3. Sign 3 on Green Grove Road, facing south, north of Bangs Avenue.

- j. *Ocean Grove School.*
- 1. Sign 1 on South Main Street, facing south, just north of Stockton Avenue.
- 2. Sign 2 on Corlies Avenue, facing west, near Memorial Drive.
- 3. Sign 3 on Main Avenue, facing east, between New Jersey and Pennsylvania Avenues.

**13-2.5 Additional Penalty in School Zones.** Residents who live in the above designated areas shall be subject to an additional fine of twenty-five (\$25.00) dollars for failure to remove any snow or ice which has fallen or formed. (Ord. No. 1448 § 2)

**EMERGENCY INFORMATION;**

When a snow emergency or any other emergency is declared, the public should monitor local radio stations 94.3 FM, 1310 AM and 95.9 FM for current conditions and any special regulations. Additionally, the public should remain alert for public announcements made by telephone messages through our Reverse 9-1-1® System and notices as deemed appropriate for the specific scenario.
