AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING A HANDICAPPED PARKING ZONE ON MT. HERMON WAY

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by adding the following:

ORDINANCE NO. 12-11

AN ORDINANCE AUTHORIZING THE GRANTING OF AN  
EASEMENT AND RIGHT-OF-WAY ON A PORTION OF BLOCK  
1001, LOT 4

WHEREAS, the property at 112 Cardinal Road is currently on a septic system and the owners desire to connect into the Township's sanitary sewer system; and,

WHEREAS, in order to access a sanitary sewer main on Robin Road, it is necessary for the property owners to install a sewer lateral through Block 1001, Lot 4, which is owned by the Township of Neptune; and,

WHEREAS, it is necessary for the Township to grant an easement of right-of-way across a portion of Block 1001, Lot 4 for a period of two (2) years to allow the property owners to install a sewer lateral,

THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Neptune

as follows:

SECTION 1

The Township of Neptune, a municipal corporation of the State of New Jersey, be and is hereby authorized to convey an Easement and Right-of-Way on a portion of Block 1001, Lot 4 for the purpose of allowing the installation of a sewer lateral to provide sanitary sewer service to 112 Cardinal Road. Said easement being further described by a metes and bounds description and survey on file with the Municipal Clerk and to be filed with the County of Monmouth.

SECTION 2.

This ordinance shall become effective immediately upon its adoption and publication according to law.
