

**TOWNSHIP COMMITTEE OF THE TOWNSHIP OF NEPTUNE  
PUBLIC NOTICE  
BOND ORDINANCE 12-24 STATEMENTS AND SUMMARY**

The bond ordinance, the summary terms of which are included herein, has been finally adopted by the Township Committee of the Township of Neptune, in the County of Monmouth, State of New Jersey on July 23, 2012 and the twenty (20) day period of limitation within which a suit, action or proceeding questioning the validity of such ordinance can be commenced, as provided in the Local Bond Law, has begun to run from the date of the first publication of this statement. Copies of the full ordinance are available at no cost and during regular business hours, at the Clerk's office for members of the general public who request the same. The summary of the terms of such bond ordinance follows:

**Title:** BOND ORDINANCE PROVIDING FOR THE ACQUISITION OF EQUIPMENT ASSOCIATED WITH THE IMPLEMENTATION OF A SINGLE STREAM RECYCLING PROGRAM, BY AND IN THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$1,100,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$1,045,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF

**Purpose(s):** The Acquisition Of Equipment Associated With The Township's Implementation Of A Single Stream Recycling Program, Including But Not Limited To, The Acquisition Of Semi-Automated Recycling Trucks And All Supporting Capital Equipment And Supplies.

**Bonds/Notes Authorized:** \$1,045,000

**Grants Appropriated:** None

**Section 20 Costs:** \$15,000

**Useful Life:** 7.27 years

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING A HANDICAPPED PARKING ZONE ON ABBOTT AVENUE, REMOVING A HANDICAPPED PARKING ZONE AT A DIFFERENT LOCATION ON ABBOTT AVENUE AND ADDING A LOADING ZONE ON OCEAN AVENUE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by adding the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Abbott Avenue	1	North side of Abbott Avenue beginning 93 feet east of the northeast intersection of Abbott Avenue and New Jersey Avenue

Volume I, Chapter VII, Section 7-21.2 - Handicapped Parking Spaces on Public Roads - Locations Designated, is hereby amended by *deleting* the following:

<u>Name of Street</u>	<u>No. of Spaces</u>	<u>Location</u>
Abbott Avenue	1	South side of Abbott Avenue beginning 25 feet east of the southeast intersection of Abbott Avenue and Lawrence Avenue.

SECTION 2

Volume I, Chapter VII, Section 7-15 – Loading Zones - is hereby amended by adding the following:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Ocean Avenue	East	East side of Ocean Avenue beginning 60 feet south of the southeast intersection of Ocean Avenue and westbound Ocean Pathway and extending 35 feet.

SECTION 3. This ordinance shall take effect upon publication in accordance with law.

AN ORDINANCE TO AMEND VOLUME I, CHAPTER VII, SECTION 7-13 OF THE CODE OF THE TOWNSHIP OF NEPTUNE BY ADDING A LEFT TURN PROHIBITION AT STATE HIGHWAY 35 AND MONROE AVENUE

BE IT ORDAINED, by the Township Committee of the Township of Neptune that Volume I, Chapter VII, Section 7-13 of the Code of the Township of Neptune is hereby amended as follows:

SECTION 1

Volume I, Chapter VII, Section 7-13 – Turn Prohibitions - is hereby amended to add the following:

Intersection  
State Highway 35  
and Monroe Avenue

Turn Prohibited  
Left

Movement Prohibited  
Monroe Avenue onto  
State Highway 35

SECTION 2

This ordinance shall become effective immediately upon its adoption and publication according to law.
