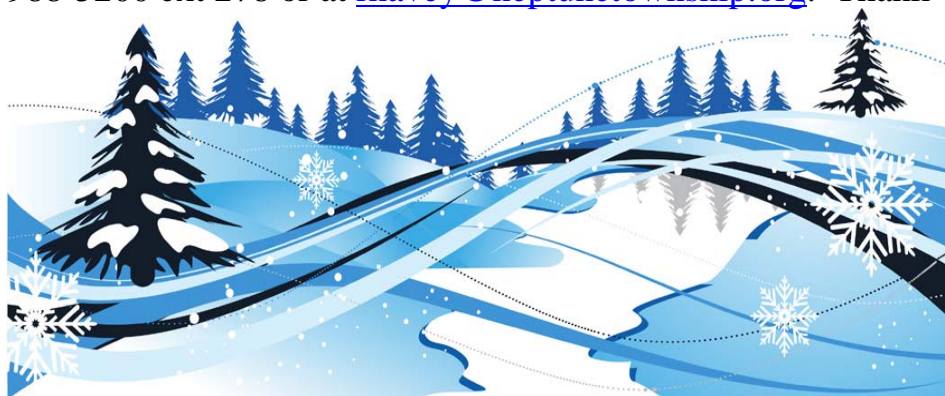
The following procedure will be followed:
