WHEREAS, PEG Bandwidth NJ, LLC intends to install its facilities on or in existing telephone, electric or cable conduit and poles in the public Right-of-Way through agreements with other utility companies or to construct underground conduit space where necessary; and

PEG Bandwidth NJ, LLC shall pay the Township of Neptune \$1,000.00 for submission of initial Occupancy Application and \$500.00 for submission of any subsequent modified or expanded Occupancy Application ultimately reviewed by the Township Engineer, and shall comply with all other requirements of Local Ordinances and State Law.

The Mayor and Clerk are hereby authorized to execute the Agreement and forward to PEG Bandwidth NJ, LLC an original of the aforesaid Agreement.
