ORDINANCE NO. 18-11

CAPITAL ORDINANCE PROVIDING FOR ROADWAY IMPROVEMENTS TO HECK AVENUE, BY AND IN THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$386,850 TO PAY FOR THE COST THEREOF, WHICH AMOUNT IS A TRANSPORTATION TRUST FUND GRANT RECEIVED OR EXPECTED TO BE RECEIVED BY THE TOWNSHIP FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION'S FISCAL YEAR 2018 MUNICIPAL AID PROGRAM

WHEREAS, the Township of Neptune, in the County of Monmouth, State of New Jersey (the "Township"), wishes to undertake a capital improvement consisting of roadway improvements to Heck Avenue, by and in the Township, and all as shall be more particularly described in documents on file in the Office of the Clerk of the Township and by this reference incorporated herein (collectively, the "Capital Improvements"); and

WHEREAS, the cost of said Capital Improvements is estimated to be \$386,850; and

WHEREAS, the Township has received or is expected to receive a Transportation Trust Fund Grant from the New Jersey Department of Transportation's Fiscal Year 2018 Municipal Aid Program in the amount of \$386,850 (the "Grant") to undertake the Capital Improvements; and

WHEREAS, the Township Committee desires to authorize the appropriation and expenditure of the Grant in order to undertake the aforesaid Capital Improvements.

BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF NEPTUNE, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

- SECTION 1. The capital improvement or purpose described in Section 2 of this capital ordinance is hereby authorized as a general capital improvement to be undertaken by the Township. There is hereby appropriated the amount of \$386,850, which amount is the Grant received or expected to be received by the Township and deposited into the General Capital Fund for said improvement or purpose stated in Section 2 hereof.
- SECTION 2. The capital improvement or purpose hereby authorized is the undertaking of roadway improvements to Heck Avenue, by and in the Township, including the reconstruction of Heck Avenue along with ancillary improvements to curbs and sidewalks, and all as shall be more particularly described in documents on file in the Office of the Clerk of the Township and by this reference incorporated herein and also including all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto.
- SECTION 3. The expenditure of the Grant for the improvement or purpose set forth in Section 2 hereof is hereby authorized and approved. The Mayor, the Clerk, the Chief Financial Officer and any other official/officer of the Township are each hereby authorized and directed to execute, deliver and perform any agreement with the New Jersey Department of

Transportation or any other agreement necessary to undertake the improvement of purpose set forth herein and to effectuate the transaction contemplated hereby.

SECTION 4. The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the office of the Clerk and is available for public inspection.

SECTION 5. Capitalized terms used herein and not otherwise defined, shall have the meanings ascribed to such terms in the preamble to this capital ordinance.

SECTION 6. This ordinance shall take effect in accordance with applicable law.

WHEREAS, the parties have addressed all OPRA concerns of the past and have reached a Consent Order allowing for the release of the Turner Report in redacted form, which avoids all of the aforesaid issues concerning disclosure previously imposed upon the governing body of the Township of Neptune; and

WHEREAS, it is the Police Committee of Neptune Township's recommendation to the governing body that the redacted Turner Report be released to the public and to Elena Gonzalez per the Consent Order.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the aforesaid Consent Order and the recommendation of the Police Committee of Neptune Township, the Mayor and Township Committee of the Township of Neptune, County of Monmouth and State of New Jersey, hereby authorize the release of the redacted report prepared by Gregory Turner in 2014, a/k/a the Turner Report to both Elena Gonzalez and to the public at large.
