# AUTHORIZE INTRA-COUNTY MUTUAL AID AND ASSISTANCE AGREEMENTS WITH PARTICIPATING UNITS IN THE COUNTY OF MONMOUTH

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et. Seq., ("Act") provides that any local governmental unit may enter into a contract with any other local governmental unit to provide or receive any service that each local unit is empowered to provide or receive within its own jurisdiction; and

WHEREAS, mutual aid and assistance agreements between municipalities, counties, law enforcement agencies, police, emergency medical service, fire departments, fire companies, or EMS organizations and fire departments situated in fire districts operated by a Board of Fire Commissioners, are permitted pursuant to N.J.S.A. 40A: 14-26 and 40A: 14-156.1; and

WHEREAS, the President in Homeland Security Directive (HSPD-5), directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System ("NIMS"), which would provide a consistent nationwide approach to Federal, State, local and tribal governments to work together more effectively and efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity; and

WHEREAS, "The New Jersey Civilian Defense and Disaster Control Act" App.A9-33 et. seq., provides for the health, safety and welfare of the people of the State of New Jersey during any emergency by centralizing control of all civilian activities having to do with such emergency giving the Governor control over the resources of each and every political subdivision to cope with any condition that shall arise out of such emergency; and

WHEREAS, The Director of the Division of Fire Safety in the Department of Community Affairs promulgated rules in accordance with the "Fire Service Resource Emergency Deployment Act," N.J.A.C. 52:14E-11 et. seq., commonly referred to as the "Fire Service Resource Emergency Deployment Regulations" N.J.A.C. 5:75A et. seq.; and

WHEREAS, the Township Committee of the Township of Neptune deem it to be in the best interests of the Township to enter into Mutual Aid and Assistance Agreements with governmental entities throughout Monmouth County and all of their departments, authorities, boards, commissions and other functions under the auspices of each participating governmental entity including but not limited to, law enforcement, public works, emergency medical services, emergency management, human services, hazardous materials response units technical or special operations teams, Community Emergency Response Team ("CERT") members, Medical Reserve Corps ("MRC") members or other volunteers and other jurisdictions defined "local governments" in the Homeland Security Act of 2002; and

WHEREAS, N.J.S.A. 40A:14-26 et seq. has authorized inter-jurisdictional mutual aid; and

WHEREAS, the Township Committee of the Township of Neptune and the Participating Units recognize the benefit of entering into an Agreement for mutual aid and assistance with each other to protect against loss, damage or destruction by fire, civil unrest, hazardous material, major criminal or emergency events, natural and man-made disaster or catastrophe and to address those situations when additional aid and assistance is needed to protect the best interests of the persons and property of each individual jurisdiction,

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune that the Intra-County Mutual Aid and Assistance Agreements between the Township of Neptune, County of Monmouth and Participating Units be and are hereby accepted; and,

BE IT FURTHER RESOLVED that the Mayor and Clerk of the Township of Neptune are authorized to execute the Intra-County Mutual Aid and Assistance Agreements; and,

# SECOND AMENDMENT TO INTERIM COST AND CONDITIONAL DESIGNATION AGREEMENT BY AND BETWEEN THE TOWNSHIP OF NEPTUNE AND BAW DEVELOPMENT, LLC

THIS SECOND AMENDMENT TO THE INTERIM COST AND CONDITIONAL DESIGNATION AGREEMENT dated as of \_\_\_\_\_\_\_\_, 2019, by and between the TOWNSHIP OF NEPTUNE, (the "Township"), having offices at 25 Neptune Boulevard, Neptune, New Jersey 07753, acting pursuant to the provisions of the Local Redevelopment and Housing Law, and BAW DEVELOPMENT, LLC, a New Jersey limited liability corporation with offices at 555 Rte. 1 South, Suite 440, Iselin, New Jersey 08830 ("BAW") (this "Amended Agreement").

#### WITNESSETH

WHEREAS (#1), the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented (the "Act"), provides a process for municipalities to participate in the redevelopment and improvement of areas designated as areas in need of redevelopment or as areas in need of rehabilitation; and

WHEREAS (#2), by Resolution #18-369, adopted on October 22, 2018, the Township Committee authorized the execution of an Interim Cost and Conditional Designation Agreement (the "Agreement") with BAW Development, LLC ("BAW"), which Agreement designated BAW as the Conditional Redeveloper for certain properties located in an area which has been determined to be an area in need of redevelopment in accordance with the Act (the "Redevelopment Area"), currently designated as Block 611, Lots 38, 39, 40 and 41, more commonly known collectively as 1718 West Lake Avenue; Block 605, Lots 1, 2, 43, 44, 45, 46 and 47, more commonly known collectively as 1620 West Lake Avenue; Block 602, Lots 13, 14 and 15, more commonly known collectively as 1715 West Lake Avenue; and Block 610, Lot 14, more commonly known collectively as 1715 West Lake Avenue; on the Tax Map of the

Township of Neptune (collectively referred to herein as the "Project Site"), and provided for the deposit of project funds to defray the Township's costs incurred in connection with the negotiation of R redevelopment Agreement with BAW for the Project Site; and

WHEREAS (#3), the Agreement was amended to add an additional parcel, Block 611, Lot 1, also known as 1700 West Lake Avenue ("Lot 1") as part of the definition of the "Project Site" that was authorized by Resolution #18-379, adopted on November 8, 2018; and

WHEREAS (#4), the Agreement presently provides that the "Interim Period" is 180 days commencing on the date of full execution of the Agreement; and

WHEREAS (#5), the Township and BAW desire to amend the Agreement so that the Interim Period is extended as set forth herein; and

WHEREAS (#6), the other provisions in the Agreement, as previously amended, shall remain unchanged.

NOW, THEREFORE, for and in consideration of the promises and of the mutual representations, covenants and agreements set forth herein, the Parties agree to amend the Interim Cost and Conditional Designation Agreement as follows:

2. <u>Interim Period</u>. The Interim Period shall be the period that commenced on October 30, 2018 and continuing thereafter until such time as a Redevelopment Agreement between the parties is executed, or it is determined by the Township that a Redevelopment Agreement cannot be successfully negotiated and executed for any reason. During the Interim Period, the Township agrees to negotiate exclusively with BAW toward the execution of a Redevelopment Agreement, which shall include all the terms and conditions, schedules, and financial arrangements between the Township and BAW. During the Interim Period, either party may cease negotiations and terminate the Agreement if the other party is not diligently negotiating in good faith or it is determined that a Redevelopment Agreement cannot be successfully negotiated and executed for any reason. In the event that the Agreement is

terminated, then neither party hereto shall be bound by any further obligations hereunder to the other, except as may exist under Paragraph 3 pertaining to the Payment of Interim Costs.
