A Resolution Directing Reassignment of Vehicle

The 1st Assistant and 2nd Assistant fire chiefs shall coordinate to assure the vehicle is used for responding to, and establishing or supporting command functions at dispatched incidents until such time as the Board may promulgate additional guidelines for the use and deployment of the command vehicle.

CLOSED SESSION MINUTES

Board Attorney James Hundley reported findings if an incident that occurred on September 9, 2017 wherein it was reported that an OGFD firefighter engaged in public conduct of a grossly inappropriate and disturbing nature in the presence of one or more Neptune Township Police Officers responding to a report of a parking violation at the Olin Street Firehouse.

In reviewing the matter, the Board Attorney considered a report provided by Neptune Township Police Department, and interviewed the one available witness. It was further noted that NTPD referred the matter for action by the Board, but declined to make the other known witnesses available to the Board Attorney. The clerk indicated that notice of the hearing was mailed to the firefighter involved, and a voice mail message was also left for the firefighter. The firefighter was not present at the meeting.

Acting on the only information available to the Board, the Board members present unanimously moved and resolved directing the clerk to issue a letter of reprimand to the involved firefighter, indicating the conduct displayed by the firefighter while at the firehouse on September 9, 2017 was objectionable, and inconsistent with the behavior the Board, and the general public, expects from firefighters.
