Rain Date: Sunday, September 27, 2015

Location: behind Neptune Municipal Building Avoid the \$20 late fee—register by September 1, 2015 Deadline for a Food Vendor to register is September 14, 2015

Food vendors will be charged \$100 per 18' by 16' space, and must meet the guidelines of the County Health Department. Food prepared in a commercial or restaurant kitchen (for which proof must be shown) may be sold; food prepared in a private kitchen may not be sold. Food vendors must complete a separate Monmouth County Health Department Temporary Food License Procedure Form (available through Neptune Recreation), and be ready for inspection by 11am on event day.

Please note there will be no electric available at the event.

Anyone <u>cooking on site</u>, will also need (by Sept 14) a separate permit from the Neptune Fire Prevention Bureau. This permit fee is a separate \$42; please download the Fire Permit Form from <u>neptunefiredept.org/forms</u>
