### TOWNSHIP COMMITTEE MEETING -MARCH 12, 2012

Mayor Bishop called the meeting to order at 6:00 p.m. and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Eric J. Houghtaling, Kevin B. McMillan and Mayor J. Randy Bishop. Absent: Mary Beth Jahn

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Michael J. Bascom, Chief Financial Officer; and Gene Anthony, Township Attorney.

Mayor Bishop announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 5, 2012, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

Bill Doolittle, Construction Official, present for a discussion on construction permit fees. Mr. Houghtaling stated that the American Legion on Gully Road has requested a waiver of construction permit fees because they have to replace boilers due to flooding from Hurricane Irene. Mr. Doolittle stated that when fees are waived, that cost has be picked up by either increased fees or increased taxes for the Construction Department budget. He stated that the Department waived \$119,000 in fees in 2011 and \$161,000 in 2010 for other governmental agencies, volunteer members of first aid and fire and Schoolhouse Square. He stated that waiving fees for non-profits could also trickle down to zoning, HPC and mercantile fees. Mr. Anthony stated that the statutes allow a fee waiver under certain circumstances. If a statute regulates an activity, then a statute must exist to allow for a fee reduction or a fee waiver. There are specific examples that allow for a waiver of construction fees and the examples are for the situations for which Mr. Doolittle has waived fees. The Township Committee does not have the ability to arbitrarily waive fees outside of the those items listed and veterans associations or groups are not on the list.

Mr. Bascom stated there have been no changes to the proposed municipal budget in the past two weeks. The budget proposed for introduction this evening has a 2.8 cents increase over 2011 which is slightly higher than 2011, but lower than 2009 and 2010. Mr. Houghtaling asked why there is a significant increase in the police salary and wage line. Mr. Bascom stated that the number of new officers moving up through the step increase is a larger percentage than normal.

The Committee discussed the possibility of having a member of the Township Committee included on the Negotiating Team for municipal contracts. Mr. Houghtaling stated that the Committee should have a game plan before starting negotiations. Mr. Bascom stated that historically there is a game plan and guidance before negotiations start. He added that the Township has been doing better with contracts than the other municipalities in the County. Mr. Bascom stated that he has been an employee under all different types of scenarios for how contracts were negotiated. Back in the 1970s and 1980s, the governing body was involved and we are still working on removing some of the items that were added to the contracts back them. Mr. Anthony suggested that the liaison to each Department meet with the Negotiating Team prior to the start of negotiations. Mr. Bascom stated that the Labor Attorney really drives the negotiations since he has extensive knowledge on what is being negotiated throughout the state. The Committee indicated that the process should remain the same as in the recent past.

The Committee indicated their opposition to changing the traffic pattern on Route 33 between Union Avenue and Walnut Street to one lane in each direction with a center turning lane.

The Committee reviewed the calendar of upcoming events and each took responsibility for attending one or more of the various homeowners associations meetings.

Mr. Houghtaling asked that drainage at 207 Monmouth Avenue be added back to the list of pending items. Mr. Bascom stated that the Township Engineer is looking into this matter.

# <u>AUTHORIZE AN EXECUTIVE SESSION AS AUTHORIZED BY THE OPEN PUBLIC MEETINGS ACT</u>

Mr. Houghtaling offered the following resolution, moved and seconded by Dr. Brantley, that it be adopted:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances; and,

WHEREAS, this public body is of the opinion that such circumstances presently exist,

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Neptune, County of Monmouth, as follows:

- 1. The Public shall be excluded from discussion of and action upon the hereinafter specified subject matters.
  - 2. The general nature of the subject matter to be discussed is as follows:

Personnel – Appointment to Housing Authority and vacancy on Library Board of Trustees Contract negotiations – Sewer Service Agreement – 112 Cardinal Road Contract negotiations – Shuttle Bus services

Personnel – Appointment of CDBG Citizen Participation Group

- 3. It is anticipated at this time that the above stated subject matters will be made public when matters are resolved.
  - 4. This Resolution shall take effect immediately.

The resolution was adopted on the following vote: Brantley, aye; Houghtaling, aye; McMillan, aye; and Bishop, aye.

The Committee entered executive session for discussion on closed session matters.

The Committee is reviewing the appointment to the Housing Authority.

Mr. Anthony stated that the Township needs to grant an easement on Township property to the owner of 112 Cardinal Road to allow them to tie into the sanitary sewer main to the rear of the property. The question is the amount of time the easement should be granted to complete the job. The Committee indicated two years.

The Committee reviewed options for summer shuttle services from to and from the Bradley Beach and Asbury Park train stations. The Committee indicated that funding would be granted for the same shuttle that was in operation last year, but no additional shuttle services would be funded at this time.

The Committee will seek members for the CDBG Citizens Participation Group. The staff that should be included is Leanne Hoffmann, Phil Huhn, Monique Burger and Michael Bascom.

The Committee returned to the Meeting Room for the regular portion of the meeting.

Mayor Bishop called the meeting to order and requested the Clerk to call the roll. The following members were present: Dr. Michael Brantley, Eric J. Houghtaling, Kevin B. McMillan, and Mayor J. Randy Bishop. Absent: Mary Beth Jahn

#### **COMMENTS FROM THE DAIS**

The Mayor requested comments from the dais and they were as follows:

Dr. Michael Brantley stated he attended the retirement dinner of Deputy Chief Bailey and it was sad to see him retire.

Kevin McMillan stated he also attended Deputy Chief Bailey's retirement party and attended the St. Patrick's Day Parade in Belmar. He had the opportunity to march with the Mayor and Deputy Mayor and he was happy that the weather held up. He attended the Legislative Committee Meeting that was held in Princeton with William Dressel. He attended the Dr. Seuss Read For America Program that was held at Thurgood Marshall School in Asbury Park. He read to fourth graders. He attended the tail end of the Dr. Seuss program which was held in our library and the Mayor and the Deputy Mayor were also there. On Saturday, he attended the finals at the Pinebelt Center with Neptune vs Plainfield and Neptune gave a valiant effort and it was really a great game however Plainfield prevailed.

Deputy Mayor Eric Houghtaling stated he attended the Shark River Hills property owners meeting and the informal gathering for Deputy Chief Bailey for his retirement. Mayor Bishop stated he attended the retirement gathering for Deputy Chief Bailey. He stated he would be missed here but was glad that he would be working in Ocean Grove. He stated he also attended the Shark River Hills Read Across America Day. He also attended the Read Across America Day at the library. He attended the St. Patrick's Day Parade it was great and the weather was great. A meeting was held concerning dredging and they brought their Legislators up to speed and Senator Beck was in attendance. He stated he appreciated her being there. He attended the Ocean Grove Beautification Dinner and it was a wonder night. He attended the Shark River Hills

Casino PTA Night and the Gables School Talent Show. He stated he was proud of the students who participated. He attended the NTEA brunch and the Gables Applebee fundraiser. This coming Friday is the Green Grove PTA's Red Carpet Auction with the Real Housewives of New Jersey. He went on to state that the Monmouth Council Boy Scout's of America was doing a fundraiser at Perkins. He stated they were also starting a new Boy's Scout Troop in Neptune.

#### PUBLIC COMMENTS ON RESOLUTIONS

The Mayor requested public comments regarding resolutions presented on this agenda.

Hank Coakley, referred to Resolution #12-130 which would give permission to Avon to dispose of dredge material at the Township's old landfill. He stated he felt that the Township was being hypocritical for allowing someone to dump in our Township.

Mayor Bishop stated the Township's problem was not the dumping of the dredge material but where they where going to dry them but Avon is going to bring dried materials from theirs and place it on our landfill. He stated they had the money to do the dredging and a place to put the material after it's dried it's that interim piece we don't have which is the place to dry it.

Mr. Coakley questioned where was Avon drying their stuff.

Mr. Bascom stated Avon has such a small amount. He stated what has to be removed in Phase I of the channel dredging they are looking to move 150,000 cubic yards.

Kennedy Buckley, commented on the municipal budget and stated that it was nice that the Township has received a nice triple a rating. He stated he has read in the newspaper where communities all over America were going bankrupt. He stated we've had a nice winter and we should have a lot of money in our snow budget. He questioned what would happen to the unused funds and could it be banked to offset other budgets in years to come.

Mr. Bascom stated those excess funds that are available at the end of this cycle will then go into a snow removal trust fund. So in the more severe years for instance last year we had money in our snow removal trust fund so when everybody else was declaring emergencies and raising additional taxes we used our budget money plus our snow removal trust fund money so that we could manage without a spike in the tax rate.

Mr. Buckley stated he did not know about the snow removal trust fund but felt that it was a great example as to how Neptune was being run. He asked them to hold the line when it came to salary negotiations.

Mr. Bascom stated for the record that was a template that they had to use from the State and they did not come up with the wording themselves. Basically what this does is give them budget flexibility. This is strictly budget management.

There being no further comments, the Mayor closed the public hearing.

## PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

Wayne Thomas, 6 White Drive, presented the Committee with pictures and complained about properties in his neighborhood. He stated that the properties were bringing down the property values in the neighborhood and was also destroying the tax base. He did not understand why Code Enforcement allowed this to go on.

Mayor Bishop stated that he would put it on the list of parking lot items and he noticed that Mr. Doolittle was present this evening and stated they would sit down and address the issues.

Hank Coakley questioned who were the judges that were involved in the dredging matter and what were their annual salaries.

Mr. Anthony stated he could not tell him who they were nor could he tell him their salaries because they have not been selected yet. He stated that it would normally be a two judge panel that hears these types of appeals.

Mr. Coakely questioned when were the courts going to do something that they were being paid to do. He also stated that he did not support the increase in the minimum wage.

Janice Sweeney, Norman Drive, stated she supported Wayne Thomas's request to have Code Enforcement canvas the neighborhood especially on Gail Drive where there were vacant homes. The grass is over grown, wild animals are living there and garbage was piling up.

Mayor Bishop requested a telephone number of someone and he would call and keep them abreast as to what was going on.

Mr. Doolittle stated he appreciated their eyes and ears and for them bringing it to their attention.

Felicia Gatson, 309 Michelle Court, stated her concerns related to and old home at 304 Michelle Court. She felt the home should be torn down and there were wild animals running around on the property.

Kennedy Buckley stated it was nice to see the Committee agree about the budgeting. He requested an update on the Koplitz Parkview Inn situation.

Mr. Anthony stated they entered into a stipulation of settlement in municipal court that has phasing. He explained the process and stated Mr. Koplitz has completed phase one and he hoped that he complied with phase two.

Julia Straughter, 301 Michelle Court, discussed the wetlands behind her property and stated the water that was running onto her property was making her property erode. She stated she's met with Township officials regarding having the banks stabilized and was told they would get back to her within two weeks but she has not heard from them since. She stated they did come out and check the sewerage. She also stated she's spoken with Wayne Rode and he hasn't gotten back to her either. She went on to state that the municipal officials said they would speak with FEMA. She stated this was beginning to be very frustrating to her.

Mayor Bishop stated Leanne was in contact with the Mosquito Commission and they had spoken about the potential of getting the equipment further down to do some work and the Mosquito Commission said they could not do it because of their type of equipment. He stated Ms. Hoffman spoke to Mr. Rode about the trees and debris that have fallen and he stated he hadn't had a chance to follow up with FEMA yet.

Mr. Anthony stated they almost need an easement to get there and there was an access problem and second of all they were responsible for maintaining the brook but they were not responsible for maintaining the property outside the brook but genuinely they do try to help out in terms of trees going into the brooks.

Mayor Bishop stated it was confusing to him as well and questioned what did the easement mean.

Mr. Anthony stated an easement meant that no one could build on it and that this was more of a conservation easement where they try to prevent people from damaging the stream area by doing things they should not be doing on it.

Ms. Straughter stated they were not maintaining the brook.

Mayor Bishop stated he would have to get every one back together to discuss this matter further so that they could get answers because it was obvious they were not giving.

Jack Pensabanne 1306 Ninth Avenue questioned whether there would be details prior to the adoption of the municipal budget.

Mayor Bishop stated the budget would be published in the newspaper and would be available on the Township website.

Mr. Pensabanne questioned what was the Township's bond rating and if they were Triple A rating.

Mr. Bascom stated the Township had three increases over the last several years and they did not have a Triple A rating. He stated Monmouth County was one of the only counties in the country with a Triple A rating. He stated Neptune's rating was A++ and their rating was different from Moody's.

Mr. Pensabanne questioned what rate did they think the Township would get for the proposed bonds.

Mr. Bascom stated it depends on when they actually decide to go out and finance it.

Mr. Pensabanne stated he felt it was be better to secure the bonds now rather than later. He also questioned whether the Township was able to establish a savings account for future projects.

Mr. Bascom stated there were trust funds for specific purposes then there were fund balances that are surplus for the entire town which was in the general fund. He stated that in the event of an emergency which causes you to exceed your budget then you appropriate money from your surplus or fund balance but then you have to replenish it depending on the type of emergency you have.

Mr. Pensabanne stated he noticed that Mr. Tirrell resigned from the Library Board of Trustees. He stated he felt he was a great guy and he hoped he was fine.

Mayor Bishop stated that he had a young child that required more of his time.

Mr. Pensabanne stated he's noticed that his area Bradley Park was really littered. He called in reference to the triangle that was located on Ninth Avenue and it was cleaned up. He questioned whether there was a group that went out to clean such things.

Mr. Houghtaling stated when they see a problem they try to address it.

Jake Gatson, 309 Michelle Court, stated the residents needed something that would keep the banks from deteriorating.

Mayor Bishop stated that was one of the reasons he wanted to meet with everyone again.

Dorothy Argyros, 2100 Rutherford Avenue, stated that her dear friend Franchesa Girolomi passed away on January 19<sup>th</sup>. She stated her dear friend always commended someone whenever they were kind to her. She stated she too wanted to commended Rick Cuttrell, Pam Howard, Rose Havey and George Waterman who assist her when she needs information. She read an excerpt from the Watch Dog and passed around copies of it.

Heinz Weck questioned whether Ms. Jahn was well.

Mayor Bishop stated Ms. Jahn's father was scheduled for surgery tomorrow and she was on her way to be with him.

Mr. Weck stated that Neptune was the envy of so many towns especially since Neptune has the Bishop and the Brain. He stated the streets near Mayor Bishop's home was in need of repair and his friend sent in a letter regarding the cemetery near her home at the Summit. They started the work but then they stopped.

Mayor Bishop stated he would look into why they stopped.

Mr. Houghtaling offered a motion, seconded by Mr. McMillan, to adjourn. All were in favor.
